KILCOOLE NEXT STAGE

Work is now underway at the Kilcoole site that will house our future Adult Day Services, Respite and Administration/Training buildings. The project has taken a long time to come to fruition and it is great to see the work finally begin. The pictures show the entrance road being constructed to the site which will allow St. Catherine's Special School to start their building and see SCA follow in the not too distant future.

Project Manager Ken MacAvoy of 3CS Project Management says 'The road will be complete to allow construction traffic by the end of June and the Tender documents for the ADS building are in final production to issue by the end of May'.

This is a great milestone to see achieved and we look forward to updating you on more as the project progresses.





Interview with Padraig Rushe

Director of St. Catherine's Association and Chairperson of the Board of Management of St. Catherine's Special School where SCA is patron

How did you become involved with St. Catherines?

Back in 2014 and just prior to retiring from Bank of Ireland I became aware of the financial issues facing the Association through my daughter Jennifer, whose son Cass now attends the School. I subsequently joined the Board of the Association and very quickly became immersed in the significant challenges facing the company. From the outset it was very clear that St. Catherine's had an excellent reputation within its community for the quality of its staff and the services they provided but that relationships with some key stakeholders were strained. It was also clear that once the issues were dealt with the organisation had a bright and exciting future and I felt that I could assist in some small way in making that a reality. **What have been the standout achievements over the past 10 years?**

First off, I think that society in general has had an awakening of sorts when it comes to the disabilities sector. By that I mean that people are now more aware of the need to accommodate everyone in as inclusive a manner as possible. The Government recognises that it needs to do more to enhance the lives of people with disabilities and enable them to reach their full potential. We have a Minister for Disabilities, changes are being made (though not nearly enough) so we are moving in the right direction.

From a St. Catherines perspective I believe we have 'right sided' the organisation and now have a strong management team and staff supporting the children and young adults under our care. Services have been expanded, and we have just commenced the construction of a new 'St. Catherine's campus' in Kilcoole and hope to see our new school construction get underway on this site this Summer. This development has been many years in the making but is now a reality and will underpin the Association and School for the next 50 years and beyond!

As our Special School celebrates its 50th anniversary what challenges lie ahead?

Over fifty years ago some visionary people saw the need to establish a school to cater for the educational requirements of children with intellectual disabilities. Getting the School recognised and registered with the Department of Education in 1975 was a magnificent achievement. Now in 2025 we are about to embark on a significant expansion of the School which will see classrooms increase in size and number and structured and equipped to meet the specific needs of our pupils. This will be a new and perhaps somewhat daunting experience for our pupils and staff. The overall management of this process presents its own challenges and once complete transitioning from the Kilmullen Lane and the EDC locations will require adept handling. Staffing numbers will increase and as is well reported recruitment is a major issue across the sector and indeed the wider educational community. I believe we need to continuously agitate for a more harmonious and seamless service from the Departments of Health and Education in order to get the best possible outcomes for our community.

Finally, can I just say that St. Catherine's is an amazing place. The dedication and devotion of our staff in caring for all of the wonderful people placed in our care is truly inspirational. Long may that continue.

Mental Health First Aid Training

SCA recently held Mental Health First Aid Training delivered by Qualtec. This course equipped learners with the knowledge and awareness on a range of mental health illnesses enabling them to recognise common signs and symptoms - *"The content was delivered well and the instructor was very engaging. CORU Registration for Social Care Workers



I am happy to report the number of staff beginning the registration process has significantly increased. SCA have had a Peace Commissioner on site to support staff in their registration process. Please be reminded that if you are employed as a Social Care Worker you are required to register with CORU before <u>30/11/25</u>. For further information on the registration process please visit <u>social-care-worker-guidance-notes-s91-1.pdf</u>

Unless you are a new graduate who has just qualified you should register under the Grandparenting Section 91 route. To be eligible:

• You must be able to demonstrate having 2 years practice in the previous 5 years on the date of application.

• Hold an Approved Qualification (click here for List Social Care Workers - Coru)

OR

 Hold a qualification that the Social Care Worker Registration Board deem to be suitable (click here for list <u>Sufficiently</u> <u>Relevant Qualifications - Coru</u>)

OR

• Hold a Schedule 3 Qualification (click here for list <u>Schedule 3 Qualifications - Coru</u>)

OR (if you do not hold any of the above)

• Employer's Opinion of Competency. This is a form your Line Manager needs to complete for you (you must have minimum of six months service with SCA for this to be completed)

OR

• If you cannot provide any of the above, a pathway known as an Assessment of Professional Competence is available. The Assessment of Professional Competence requires applicants to undergo an assessment of their professional competence. More information on this can be found <u>Assessment of Professional Competence - Coru</u>.

Our sincere thanks to all of the parents and guardians who took the time to respond to our Respite and Residential Services Family Feedback Survey for 2024. The response rate was up 34% on the previous year which was fantastic to see – the more input we receive, the more informed we are in shaping our services to best meet the needs of those in our care.

This year, all responses were considered under St. Catherine's core values of compassion, integrity, innovation and dedication. The results are in and show us the two values we performed best in were compassion and innovation with satisfaction levels of 99% and 94% for respectively. This was followed closely by integrity and dedication at 93%.

This survey also gave families the opportunity to suggest areas that we could improve, and we have listened. Over the next number of weeks, local centres will be in touch with new initiatives in response to this invaluable feedback.
